

Gayton Neighbourhood Development Plan: Questionnaire Introduction: What is a Neighbourhood Development Plan?

Neighbourhood planning was introduced by statutory powers within the Localism Act 2011, which enables communities to have greater control of the way they develop. A Neighbourhood Development Plan (NDP) is a document that sets out the policies for the neighbourhood area which are used to guide the outcome of planning applications. The Plan is written by the local community, the people who know and love the area, and not the local planning authority. It is a powerful tool designed to help the community get the right type of development, in the right place. The three main steps to creating a neighbourhood plan are:-

Step 1: Getting set up and defining the neighbourhood area.

Step 2: Community consultation and evidence gathering.

Step 3: Submission of the proposed Neighbourhood Development Plan to an external examiner and West Northants Council for approval.

This questionnaire comprises the main part of the consultation process, step 2. It has been created by:-



Recreation and open spaces

Gayton currently has the following outdoor spaces that can be used for recreation:

- The Millennium Spinney that is maintained by a working party of residents and owned by the Parish Council.
- Gayton Allotments, owned by the Church and rented to the Gayton Gardening and Allotment Society.
- A village green, incorporating a small football field, that is well used, managed and maintained by the Parish Council.
- A play area that too, is managed and maintained by the Parish Council.
- A network of footpaths and bridle ways that are maintained by local volunteers and WNC. These footpaths are a real asset to the community and the Eykyn Arms could theoretically become a hub for walkers and cyclists.

The Grand Union Canal passes through the northern part of the parish. The towpaths can be walked from Gayton in both directions and into Northampton via the Northampton Arm. We have a good relationship with the Canal and River Trust who use the hazel coppiced from our spinney to build fences by the towpath.

The roads around the village are used by cyclists and horse riders, although speeding motorists occasionally make this a somewhat hazardous pastime.
