## **Gayton & Tiffield Community Minibus**

This update is written as our nation tries to come to terms with the loss of our amazing Monarch, Queen Elizabeth II. There can be no better example in our lifetime of such selfless dedication to Public Service than the one she has provided us with, and I believe it has been an absolute privilege for us all to have experienced this.

With the sad loss of our Queen and the earlier village celebrations to mark the Queen's Platinum Jubilee, it has certainly been a remarkable year which will live long in our memories.

Following the highly successful Gayton Open Gardens festival held on Sunday 12 June where we provided our minibus shuttle service, we also enjoyed providing our Minibus Shuttle service for the equally successful Tiffield Open Gardens event held on August Bank Holiday Monday. Despite it being held later than usual on a Bank Holiday, it was extremely well attended, and our minibus shuttle allowed visitors, including the elderly and those with small children, to visit the more remote gardens located just outside the village areas.

Hopefully we will soon be able to plan to commence a regular Tuesday and Friday service to an extended local area to enable us to provide an increase in our passenger numbers which will provide increased future income. Sadly, our plans have again been impacted by further WNC staff shortages, but we are fortunate to have built our financial reserves to a very good level by virtue of guaranteed revenue from WNC at pre-Covid levels, which continues until March 2023.

We will be arranging and publicising a date in October for our AGM to be held at Gayton Village Hall to approve our accounts and to elect a new team of Officers and Trustees to re-invigorate and extend our current passenger base to ensure we can continue to meet the needs of our local and nearby village communities.

Cate Gardner has continued to provide a superb service as our Treasurer. Steve Jowers from Tiffield and David Coppock, Jens and Manja from Gayton have as ever provided excellent support in sustaining our services through recent very challenging times and of course our thanks to all our volunteer drivers for their unstinting support and assistance in providing our much-valued Community Minibus Service.

#### **Gayton Village Hall Management Committee**

Chairman's Report 2022. The village hall use has now returned to that of pre-covid times, except we have a new person in charge of day to day running – details are on the village website <a href="http://www.gayton-northants.co.uk/services/villagehall.html">http://www.gayton-northants.co.uk/services/villagehall.html</a> .

Many thanks to all who completed the 2021 'Village Hall Questionnaire'. The management committee want to manage the hall wisely and we engaged a property surveyor who provide a report detailing what works need completing to keep the village hall in a sound state. The questionnaire responses revealed a majority believed our village hall was still suitable and just required modest modernisation. The property survey agreed with the questionnaire results – no major structural issues were detected and a list of recommended 'repairs' was compiled. The next stage is to replace windows and doors.

Table Tennis, Yoga, Pilates and Show Dog training classes have been running on a regular basis out of the village hall. We are expecting a steady increase in use with more children's parties and fund-raising activities.

## The re-launch of Gayton Church Heritage Trust Events

Gayton Church Heritage Trust (GCHT) was set up in 2005 as a registered charity to maintain and improve the fabric of the church and ensure it remains in use by the community. All monies raised by the Trust are solely for the upkeep of a building of historical significance, a community venue and a place of worship.

Alongside the Parochial Church Council (PCC), the Trust has raised funds from grants, donations from the community and events to fulfil this aim. The improvements to date include; making repairs to the roof, upgrading the internal lighting, installing a roof alarm, resurrecting the weather vane, and building the toilet and servery.

The support of GCHT in maintaining the fabric of the building has meant that the PCC has been able to use their income from collections at services, regular monthly giving, donations, and fees from weddings, funerals and fundraising to pay for day to day running costs such as insurance, heating, lighting, water and for their Parish Share which pays for a vicar.

Working with the PCC, the Trust wants to raise monies to further enhance the church facilities as intended in the village plan. These include New heating, Reordering of the North Aisle to create a space for events, General maintenance, Storage cupboards and Seating.

The Heating project and re-ordering of the North Aisle is estimated to be about £60,000. GCHT has already has some money from bequests and fund raising. The Trust will be able to apply for grants. However we also need support from the community. Funding bodies are very keen to know that the community is supporting the project before they will award a grant.

We are now planning regular events in the Church following the disruption caused by the pandemic.

GCHT is organising a re-launch event in the Church on Friday 7th October 2022 at 7.30pm for Wine and cheese. All are welcome to attend. Please come along and support the work of GCHT Trust and be a Guardian of Gayton Church.

## **Gayton Alms Charities**

Gayton Alms Charities have been established for over 100 years. Today they are called the 'Gayton Relief in Need Charity' and the 'Gayton Educational Foundation'.

Gayton Relief in Need Charity. This charity exists to provide assistance to any person living in the Parish of Gayton\* who for whatever reason find themselves in need, hardship or distress. Usually this assistance is financial, with money paid directly to the successful applicant. Examples of where this charity might be able to help are with the purchase of food, clothing, heating costs, and grants to assist with funeral expenses.

Gayton Educational Foundation. This charity exists to provide assistance to people living in the Parish of Gayton\* who for whatever reason find themselves in need of financial help with their education. Continued .....

Money may be paid directly to the successful applicant but the trustees are able to grant money to organisations in the Parish of Gayton whose purpose is to educate or improve the lives of people through leisure-time activities.

Examples of where this charity might be able to help are in the provision of books, equipment, computer software, IT hardware, musical instruments, travelling expenses, music or dance tuition, residential educational experiences, university fees or anything else not normally provided or funded by an educational institution such as a school, college or university.

The charities receive their modest income from land rents and returns on investments. Trustees meet twice a year to review income and expenditure, and to consider application for assistance under the terms of the scheme for administering the charities.

Any villager who feels they might be eligible for help under the terms of either of the Gayton Alms Charities should contact the Chair of Trustees who will provide the appropriate application form. The Chair of Trustees is happy to offer general advice about an application and/or assist with the completion of an application form.

\*In exceptional cases the Trustees may give assistance to people living outside the Parish of Gayton. These people must be able to satisfy the trustees that they ought to be treated as if they lived in the Parish. David Coppock, Chair of Trustees (01604 859645)



## Solar Farm

In the year since Gayton Parish Council carried out a consultation regarding the proposed solar farm near the village, circumstances regarding energy prices and supply security have changed dramatically.

- Supply problems, particularly for gas, have been caused by the Russian attack on Ukraine. Gas is still by far the dominating source of energy for UK electricity generation, and for domestic heating.
- 2. Domestic energy prices have more than doubled, even after the government intervention.
- 3. Higher energy prices in general have had a knock-on effect on the prices of almost all other products, leading to high inflation rates. This makes the quest for additional electricity generation capacity, not based on gas, even more urgent.
- 4. There was a near collapse of the electricity distribution network during the heatwave in July caused by increased demand and insufficient generation. According to a newspaper report (the "i" 26/7/2022, page 42) the wholesale spot price for electricity was higher than normal by a factor of 50 for a period.
- 5. If heatwaves become more frequent, substantial amounts of electricity will be required for cooling. Solar generation is perfectly correlated with the demand for cooling.
- 6. There is increased encouragement from our elected politicians to switch from petrol and diesel to electric cars, and from gas and oil burners to heat pumps, and this will lead to a further increase in the demand for electricity.
- New nuclear power stations are under construction and planning, but they will take years to complete and will only replace the old ones which are already past their original design life.

Our current energy crisis cannot be solved by solar panels alone, but they can make a very significant contribution within a relatively short time. Blocking large scale deployment of solar panels will prolong the crisis unnecessarily.

I submitted a comment of support for the plan to WNC, but this was not listed in the committee report and appears not to have been taken into account, and in addition, the stated number of objections does not agree with the case file. On this basis I have submitted a formal complaint to WNC.

The planning officer at WNC recommended the planning application for the solar farm be refused by the Strategic Planning Committee at its meeting on 12<sup>th</sup> September. This decision has now been deferred.
